# 8. The Chair's Address and Report

The following report was shared by Anne Mathewson:

"The 2023-2024 period marked a pivotal year of transformation for Bowls Canada Boulingrin, laying a strong foundation for future progress as we reached the halfway point of our ambitious strategic plan. This year positioned us to achieve significant milestones in the final two years, both on and off the green, driving lasting impact and growth across the organization.

We saw significant progress in our membership growth. Not only have we returned to prepandemic membership levels, but five of our nine provinces have reported membership numbers that exceed those from 2019. This growth is a testament to the resilience of our community and the efforts of clubs and PSOs across the country to welcome new and returning members back to the greens. We applied the Provincial bodies and the local clubs in the promotion, recruitment and retention efforts.

In addition, we were awarded a \$78,000 grant through the Community Sport for All (CSAI) initiative, which significantly supported the development of the Diversity and Inclusion Pillar of the "Belonging in Bowls" program. This funding created a resource tool for clubs that will help expand access to lawn bowls for underrepresented communities, fostering a more inclusive and diverse sport for everyone. And I am excited to announce the first resource will be piloted with a handful of clubs next year!

Another highlight of 2023 was the launch of the BCB E-Store, which became fully operational this year. We are pleased to report that 132 orders were placed, generating a total of \$9,060 in sales. The E-Store not only provides a convenient platform for clubs and members to access essential resources but also contributes to the financial sustainability of Bowls Canada.

We rolled out the Club Development Pillar as part of the "Belonging in Bowls" program. This includes two new e-learning modules focused on recruiting and retaining volunteers and enhancing club management practices. These resources will empower clubs across the country to strengthen their operations and better serve their members.

This year also saw significant changes in our leadership team. Bowls Canada, with the help of Sport Law, contracted Mary MacDonald as Interim CEO and successfully recruited Britany Gordon to take over as CEO starting in January 2024. We bid a fond farewell to our outgoing CEO, Anna Mees, who has been an exceptional leader for the past decade, and to Alec Deschamps, our Events and Communications Coordinator. We are incredibly grateful for their contributions and dedication to the organization.

The Board itself has undergone changes, saying goodbye to Kathryn MacGregor, who has served Bowls Canada with distinction for the past nine years. As I stepped into the Chair role, Laura Seed was appointed as Secretary, and we welcomed two new directors to the Board, Jane Blaine and John Aveline.

As part of our commitment to good governance, the Board of Directors participated in a professional development workshop on Governance excellence, led by Rose Mercier from The Governance Coach. This session provided valuable insights and tools to help guide the Board in its oversight and strategic leadership role.

We look to the future with excitement and with the wisdom that has been garnered from this past year's experiences, ensuring that Bowls Canada continues to grow, evolve, and thrive. I am incredibly proud of what we've accomplished this year and am confident that we are on a strong path toward an even brighter future.

Thank you to our dedicated staff, our athletes, and our member clubs, as well as to our valued partners, including the Government of Canada, sponsors, and donors who support our mission. It has been an honour to serve as Chair, and I am excited to see where Bowls Canada goes from here."

# 10. Treasurer's Report and Financial Statements

- The following financial documents were circulated prior to the meeting:
  - o BCB Final Statements 2024
  - o Treasurer's Report 2024
  - o BCB Investment Funds Report 2024
  - o 2024-25 Budget Approved
  - o 2024-25 Approved Plan
- Bowls Canada Treasurer Dennis Verge shared that he had reviewed the financial statements in collaboration with the Audit and Finance Committee in his role as chair of the committee. The Committee agreed the statements are an accurate financial representation of Bowls Canada Boulingrin for the fiscal year ending March 31, 2024, and as such the statements were accepted by the Board. Other notes included:
  - A challenging year with extraordinary costs including world championships and recruitment of new CEO.
  - Offsetting these costs were income from investments, Government of Canada CEBA loan income, and last-minute influx of revenue from Sports Canada.
  - These costs and revenues were off set to leave Bowls Canada with a small profit for the year.
- Dennis also noted in the Annual Investment Report the following:
  - o Our investments mirrored the financial markets and showed significant growth.
  - The goal for long term investments continues to maintain a ratio of 70% equity and 30% fixed income as recommended by the BCB financial advisors and supported by the BCB Board.
  - For short term investments, BCB has been able to take advantage of rates in excess of 5% when they came due. GIC rates are now declining and are expected to decline further which will reduce fixed income on investments in the future.

- Dennis shared highlights of the 2024-25 Operational Budget and Plan:
  - Continued effort on empowering members and their stakeholders to recruit and retain bowlers across Canada while remaining a compliant, competitive and recognized NSO

## 12. Other Reports

- Provincial Reports were circulated in the AGM Meeting Package as submitted.
- Questions and Comments:
  - Thank you from Britany for all the reports. Timing of the reports was challenging.
     If there are any updates such membership totals, please let Britany so that she can have an accurate number.
  - Provinces collect demographic data differently across the country, namely as it relates to age demographics (the grouping of ages, etc). BCB recognizes this and asks that the provinces submit their best estimates using the age ranges asked by BCB.
  - Ralph Ellis commented on the new SAM database system that is being implemented in Ontario. Initially members did not want to provide their DOB but currently ages are fairly accurate.
  - o If provinces don't have the necessary data but must provide information, then Ontario's data is probably a good estimate.
  - BC member ages are dropping. Each year they put an emphasis on recruitment of individuals who are 5-10 years younger than their current average age.
  - Anne Mathewson asked Gloria McLaughlin (NB) about the gender free event that they
    held. Gloria McLaughlin will get more information on the results of this event. SK also
    held such an event.

- No nominations from the floor to fill the vacant positions.
